This Prospectus Supplement No. 3 supplements the Prospectus dated March 29, 2006 (as supplemented by Prospectus Supplement No. 1 dated May 31, 2006, and Prospectus Supplement No. 2 dated June 30, 2006) relating to the offer and sale of (i) up to 5,150,000 shares of our Common Stock, par value \$0.001 per share, issuable upon the conversion or redemption of, or as interest payments on, our 7% Convertible Debentures (the "Debentures") and (ii) up to 2,150,000 shares of our Common Stock issuable upon the exercise of Common Stock Purchase Warrants (the "Warrants"). We issued and sold the Debentures and Warrants on February 14, 2006.

The Debentures state that we may elect to make redemption and interest payments thereunder in cash or shares of our Common Stock. On July 27, 2006, we provided notice to the initial holders of the Debentures that we have elected to pay the interest and principal due September 1, 2006 in shares of our Common Stock.

This prospectus supplement should be read in conjunction with the Prospectus dated March 29, 2006, which is to be delivered with this prospectus supplement. All capitalized terms used but not defined in this prospectus supplement shall have the meanings given them in the Prospectus.

**Investing in the shares of Common Stock issued pursuant to the Debentures or upon exercise of the Warrants involves substantial risks. See "Risk Factors" beginning on page 4 of the Prospectus dated March 29, 2006.**

Our Common Stock is listed on the American Stock Exchange under the symbol "PRW". The last reported price of our Common Stock on July 27, 2006 was \$2.37 per share.
